01. The Chairman, Standing Cabinet Appointed Procurement Committee of the Ministry of Law & Order and Southern Development on behalf of the Secretary / Ministry of Law & Order and Southern Development, 14<sup>th</sup> Floor, Suhurupaya, Sri Subhuthipura Mawatha, Battaramulla, Sri Lanka now invites sealed bids from eligible and qualified bidders for the following procurements for Special Task Force of Sri Lanka Police.

02. Bidding shall be conducted through International Competitive Bidding (ICB) Procedure and the biddings only through Local Agents/Joint Ventures in Sri Lanka are allowed. Failure of submission through Local Agents/Joint ventures in Sri Lanka will result to consider as non-responsive bid. In relation to the procurement No: 02, the bidder can quote for any type of vehicle, but the bidder shall quote for total requested quantity of each item. The source of funding is Government of Sri Lanka (GOSL).
03. Bids will be invited from the International Manufacturers / Exporters but bids should be submitted through their Local Agents/Joint Ventures in Sri Lanka and the following basic qualification requirements should be possessed by the Manufacturer/Local Agent or Joint venture in Sri Lanka.
- i. At least 05 years' experience with 02 similar nature contracts at a cost indicated in the bidding documents (Manufacturer /Local Agent / Joint venture)
  - ii. Ability to provide International Warranty with 10 years spare parts availability by the Manufacturer. The presence of Agent's after sales, care and maintenance Workshop in countries where UN Missions are located, specially in the African Continent.
  - iii. Submission of audited financial reports for previous 03 years. (Both Manufacturer /Local Agent / Joint Venture in Sri Lanka)
  - iv. Bidder, who does not manufacture or produce the goods, shall submit Manufacturer Authorization using the form included in Section IV of bidding documents.

- v. The Manufacturer/Local Agent should be a registered supplier in the UN. Proven Documents should be submitted with bidding documents. All the items should be compatible with the UN Standard. 04. Delivery period of the goods shall be within three months (Maximum) from the date of signing of contract.
05. The Bidder shall not have a conflict of interest and bidder's name shall not be included in the list of debarred firms at the National Procurement Agency / Department of Public Finance. The Bidder/Local Agent shall consider the requirements under the Public Contract Act No. 03 of 1987.

The Local Agent / Joint Venture in Sri Lanka should produce the Power of Attorney of the Manufacturer/Principal.
- Only a single set of bidding documents for each procurement shall be issued for an Institution.
09. Bids in duplicate (Original / Duplicate) perfected in English Language must be delivered to receive the under noted officer at the address mentioned below or inserted in to the tender box kept at the Procurement Section at the same address on or before 1000 Hours in Sri Lanka Time, on 30.06.2017 (prior to time of the bid closing) and the Reference Number of the procurement should be indicated in the envelopes. Late bids will be rejected. Bids will be opened immediately after the closing of bids on 30.06.2017 in the presence of the bidders' representatives who wish to attend. The representatives who will attend on behalf of the bidder should produce an authorized letter from the organization. Failure to submit an authorized letter will result to miss permission for the participation at the bid opening.

10. The Bids shall remain valid until the date specified in the Bidding Data Sheet (BDS).
11. All Bids shall be accompanied by a Bid Security at the amount indicated above and it shall be;
  - i. Issued by any Commercial Bank operating in Sri Lanka and approved by the Central Bank of Sri Lanka or obtained by a reputed bank based in another country, but the guarantee shall be enforceable through Central Bank of Sri Lanka approved Commercial Bank operating in Sri Lanka.
  - ii. In favour of Secretary / Ministry of Law & Order and Southern Development.
  - iii. In the form included in Section IV of the bidding documents,
  - iv. an unconditional, on demand bond and
  - v. shall be valid up to 26.10.2017.
12. Pre - bid meeting will be held on the dates and times mentioned above at the Conference Hall of the Ministry of Law & Order and Southern Development, Suhurupaya (14<sup>th</sup> Floor), Sri Subhuthipura Mawata, Battaramulla, Sri Lanka.
